Tzu Chi University Guidelines for Setting up the Internship Committee of Department of English Language and Literature

第一條 本系為協助處理本系實習有關事務,特設置「實習委員會」(以下簡稱本會)。 Article 1—The Internship Committee — hereinafter referred to as the Committee — is an independent departmental unit founded to assist in matters related to internships.

第二條 本會之組成如下:

Article 2 – The Committee members shall consist of the following:

- 一、本會置委員3至5人,由本系專任教師於系務會議推舉產生,任期1年,連選得連任。 A total personnel count of three (3) to five (5) persons; consisting of elected personnel from the Department's presently available pool of lecturers. Elected personnels are subject to an one (1) year term and shall be eligible for re-election.
- 二、本會置召集人,由所有委員互相推選產生,任期1年,連選得連任。
 A Chairperson will be elected by the Committee members. The Chairperson will hold the position for one (1) term, lasting one (1) year, and shall be eligible for re-election.
- 三、本會視議案需要得邀請學生及相關人員列席。 Student(s) representative(s) and relevant personnel(s) may be invited to attend if deemed necessary.

第三條 本會職掌如下:

Article 3 – The committee will be responsible for the following:

- 一、整體規劃及推動校外實習課程 Planning and promotion of the off-campus internship program (course).
- 二、確認合作機構之評估結果及選定 Matters of selection, evaluation, and confirming possible locations of internships.
- 三、擬訂書面契約及學生個別實習計畫。
 Formation of written contracts, and designing individual internship plans for students.

- 四、協調、處理學生申訴、爭議及意外事件。
 - Coordination and handling of any student complaints, disputes, and accidents.
- 五、處理學生實習期滿前之終止實習。

Handling of any cases of students prematurely terminating internship contracts.

六、追蹤處理及檢討學生實習輔導訪視結果。

Tracking and reviewing the advisor(s)' report(s) and on-site visits to the students' location of internship.

七、其他學生權益保障相關事項。

Other matters related to the protection of students' rights.

第四條 本會每學期至少召開會議一次,得視需要召開臨時會議。

Article 4 – The Committee is to hold a minimum of one (1) meeting per semester, and may hold additional ad hoc meetings if deemed necessary.

第五條 本會應有超過半數委員出席方得開會,出席委員超過二分之一同意方為議決。對決議 案應有三分之二以上出席,過半數同意使得覆議。

Article 5 – Over half of Committee Members must be present to constitute a meeting. For a proposal to pass, over half of the presented Committee members must vote "agree". A proposal is eligible for reconsideration if over two-thirds of the Committee Members are present in the meeting and over half of the Committee Member.

第六條 本辦法經系務會議、院級實習委員會議審議通過,送校級實習委員會審議通過後實施, 修正時亦同。

Article 6 – All measures and future amendments must be approved by the Department Affairs Meeting, the College-level and University-level Internship Committees before final implementation.
